

## AMENDMENT NUMBER 1 to WORK ORDER NUMBER 1

This Amendment Number 1 to Work Order Number 1 (the “Amendment”) amends that certain Work Order Number 1 dated June 27, 2022. This Amendment is entered into as of the date of final signature of the Parties below, by and between the Board of Education of Queen Anne’s County, doing business as and known as **Queen Anne’s County Public Schools** (“QACPS”), located at 202 Chesterfield Avenue, Centreville, MD 21617, and **Queen Anne’s County Government** (“QA Government”), located at 107 N. Liberty Street, Centreville, MD 21617 (collectively referred to as the “Clients”); and **Everside Health, LLC** (“Everside”), a Delaware limited liability company located at 1400 Wewatta Street, Suite 350, Denver, CO 80202. Clients and Everside are each individually a “Party” and collectively the “Parties” to this Amendment.

**WHEREAS**, the Parties entered into Work Order Number 1, pursuant to which Everside agreed to provide certain health center and wellness services to Clients; and

**WHEREAS**, the Parties wish to amend Work Order Number 1 to add language allowing participation by other state, local, and nonprofit entities under Maryland law;

**THEREFORE**, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Parties agree to amend the Agreement as set forth below:

Effective as of June 27, 2022:

1. A new Section 8.22 shall be added to the Affiliation Agreement as set forth below:

8.22 Participation in this Agreement by other State, Local, and Nonprofit Entities (“Piggybacking”) under Maryland Code, State Finance and Procurement § 13–110.

Any state, local, or nonprofit entity shall be allowed to adopt the terms of this Agreement, even if said entity is not listed among the participants of the request for proposal that forms the basis of this Agreement. This section shall allow other such entities, at their discretion and the discretion of Everside, to make use of Queen Anne’s County Public School’s and/or Queen Anne’s County Government’s competitive process and purchase directly from Everside. All purchases made by other such entities shall be understood to be transactions between that entity and Everside; Clients shall not be responsible for any such purchases. Staffing and pricing models may vary according to the particular needs of each entity.

2. The Parties hereby stipulate and agree that unless specifically modified herein, the terms and conditions of Work Order Number 1 shall remain in full force and effect.


